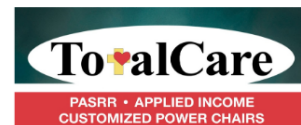

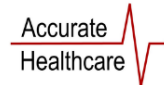

This is a new audit process. CMS will randomly request data for 10 claims from 10% of the SNFs nationwide each year, beginning this fall. The Help Desk has already been established and is active. SNFs need to be aware of how to know when their records have been requested. The sole notification will be through the iQIES system, where notifications will appear in provider preview report folders. If the SNF does not submit the requested medical records within 45 days of the notice in the iQIES folder, the SNF will lose their 2% annual Payment Update for each claim for the next fiscal year.
